Rule 2.2.2 of the Individuals Rulebook (INDI)

CONDITIONS

This notice is given on the following conditions:


- (A) The Approved Individual carrying out the Money Laundering Reporting Function (MLRF) for Global Investment House spends an appropriate portion of his time in the state having regard to the responsibilities that the MLRF entails; and
- (B) Global Investment House does not commence any Regulated Activities in or from the Qatar Financial Centre until it has appointed an Approved Individual carrying out the MLRF who is resident in the State.

INTERPRETATION

The provisions in this notice are to be construed as if these provisions are provisions of the Rulebooks.

Defined terms are identified in this notice by the capitalisation of the initial letter of a word or of each word in a phrase and are defined in the Interpretation and Application Rulebook (INAP). Unless the context otherwise requires, where capitalisation of the initial letter is not used, an expression has its natural meaning.
