**Effective Date:** This notice comes into effect on 13 March 2008 and expires on 30 June 2008.

Rule 2.2.2 of the Individuals Rulebook (INDI).

## CONDITIONS

This notice is given on the following conditions:

- (A) the Approved Individual carrying out the Money Laundering Reporting Function (MLRF) for EFG-Hermes Qatar LLC spends an appropriate portion of his time in the State having regard to the responsibilities the MLRF entails; and
- (B) EFG-Hermes Qatar LLC does not commence any Regulated Activities in or from the Qatar Financial Centre until it has appointed an Approved Individual carrying out the MLRF who is resident in the State.

## INTERPRETATION

The provisions in this notice are to be construed as if these provisions are provisions of the Rulebooks.

Defined terms are identified in this notice by the capitalisation of the initial letter of a word or of each word in a phrase and are defined in the Interpretation and Application Rulebook (INAP). Unless the context otherwise requires, where capitalisation of the initial letter is not used, an expression has its natural meaning.
