1. This guidance is for QFC Authorised Firms. You are advised to read the introductory sections from paragraphs 2 to 30 first. The rest of the guidance is divided into sections tailored to different types of firms. You only need to read the sections applicable to the nature of business of your firm. 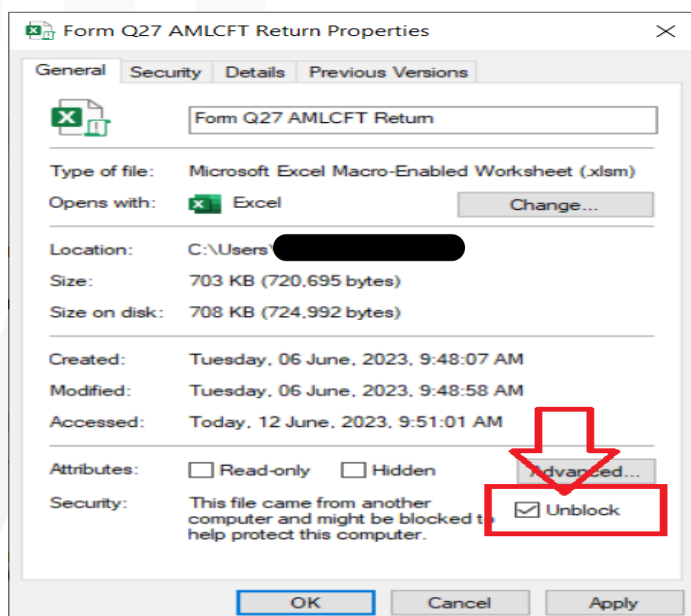
## Background

2. The purpose of the Q27 AML/CFT Return (Q27) is to provide the Qatar Financial Centre Regulatory Authority (QFCRA) and National Anti-Money Laundering and Terrorism Financing Committee (NAMLC) with all relevant data in connection to the firm's business activities. This includes information about customers, products, interface and jurisdictional Money Laundering (ML) and Terrorism Financing (TF) risks associated with the firm.
3. The Q27 must be submitted by 31 January each year, covering the previous calendar year.
4. The Q27 is primarily a quantitative data return. Some qualitative elements from previous returns have been removed e.g., firms are no longer required to complete a self-assessment questionnaire or provide a description of their business risk assessment methodology. These elements will be reviewed through other supervisory tools, such as thematic reviews or offsite and onsite assessments. The non-resident MLRO report sheet and the Representative Office AML Return are the only sheets in the Q27 where free-form, qualitative responses are required.
5. There are additional data points in the Q27 e.g., on the Products sheet, firms are required to report the number of customers using a particular product.
6. The Q27 must be submitted via the Electronic Submission System (ESS). The submission process includes a data validation process – further details are set out in the [How to submit the Q27 Return](#) section below.
7. The taxonomy used for the Q27, data validation rules and the contents of all drop-down lists for all Sheets are available [here](#).

## How to create a tailored Q27 according to the firm's type of business

### Download the Q27 template, unblock and enable content

8. A template Q27 is available from the regulatory submission page in the Electronic Submission System (ESS). Download the template form and save it on your computer using this format: FIRM NAME RETURN YEAR Q27 Return, e.g., XYZ Bank 2024 Q27 AML Return is the file name for the return submitted by XYZ Bank on 31 January 2025 covering the period 1 January to 31 December 2024.
9. The Q27 return is an Excel workbook with macros that create a tailored form based on the answers given on the front sheet (firm type, nature of business, MLRO residency etc.) Security settings on your computer may prevent the macros from running, which will prevent the form from opening properly.
10. To allow the macros to run, you may need to:
  - a. right click on the file name and select "Properties" from the bottom of the pop-up menu; and
  - b. go to the General tab of the dialog box and check the "Unblock" box at the bottom right.



11. Now, open the Q27 in MS Excel. At the top of the document click "enable content".

Complete the Front Sheet and Declaration to create a tailored Q27 depending on the firm's type of business

12. Using the drop-down lists, choose the following in the order specified (i.e., a, then b, then c, then d):
  - a. Firm Type (Authorised or DNFBP);
  - b. Nature of Business (e.g., Bank);
  - c. Did the firm file any STRs during reporting period; and
  - d. Country of residence of MLRO.
13. Complete all the other information on the Front Sheet and Declaration. Items marked \* are mandatory.
14. Where items marked \* cannot be completed (e.g., a representative office is not required to have a DMLRO), then respond not applicable or provide an explanation depending on the context.
15. After you complete the front sheet, a tailored Q27 form will be created for your firm, depending on the type of business. All the sheets relevant to your firm will be created as separate tabs at the bottom of the screen.
16. If you answered "Yes" to the question "Did the firm file any STRs during the reporting period", a STR sheet will be created and must be completed.
17. If the firm has a MLRO who resides outside of Qatar, a non-resident MLRO report sheet will be created and must be completed.

## General guidance for entering valid data

18. The following general requirements apply to entering data in all sheets:

- a. Use drop-down lists – this ensures consistency of data.
- b. You can paste data into a sheet, instead of using the drop-down lists, however if the data does not match a drop-down item, an error will be generated when the form is uploaded to ESS. As set out [below](#), a validation report setting out the errors will be produced by ESS and the firm must correct these errors before ESS will accept the submission.
- c. All currency amounts must be in Qatari Riyals.
- d. Currency is reported in actual amounts, **NOT** thousands, e.g., one hundred thousand riyals should be reported as 100,000.
- e. Do not use the currency symbol 'QAR' – just enter an amount.
- f. In number cells, insert only numbers.
- g. Express decimal places to 2 decimal places.
- h. If there is no activity to be recorded, insert "0" for number cells and "N/A" for text cells.
- i. If any data is inserted into a row, all cells in that row must be completed – cells cannot be left blank.

## How to submit the Q27 Return

19. The Q27 must be submitted via ESS. Here is a link to the ESS User Guide: [QFCRA Electronic Submission System User Guide.pdf](#)
20. The link to submit the Q27 Return will be published in the firm's Reporting Schedule in ESS in January of each year.
21. Commencing in 2024, a data validation process will take place when the firm uploads the Q27 to ESS. The firm will not be able to electronically sign the Q27 and proceed to final submission until the data validation process is completed, without errors.
22. The validation process has two parts: front-end validation and back-end validation.
23. Front-end validation checks the information on the Front Sheet and Declaration is valid, including that the firm's name on the Sheet is exactly the same as the firm's name in ESS. Front-end validation will take only a short time.

24. If there are any validation errors, the firm will receive a notice which will request the firm to log into ESS and download the validation report, which will specify what the validation errors are. The firm must correct all validation errors and then upload the Q27 Return again.
25. Once the front-end validation is complete without errors, back-end validation will commence.
26. Back-end validation checks that the information in all other sheets is valid, consistent and error free.
27. Because of the complexity of the back-end validation, including cross checks between Sheets, the validation process may take some time.
28. If there are any validation errors, the firm will receive an email which will request the firm to log into ESS and download the validation report, which will specify what the validation errors are. The firm must correct all validation errors and then upload the Q27 Return again. This process will continue until all errors are corrected.
29. Firms will receive a notice once all validation processes are complete, without error. At that time, you can log back into ESS to complete the final Q27 submission process and electronic sign-off.
30. One of the following Approved Individuals **must** electronically sign the declaration section of the Return:
  - a. Senior Executive Function;
  - b. Money Laundering Reporting Officer; or
  - c. Compliance Oversight Officer.

37. **General instructions:**
- Use the drop-down lists provided. Firms can type or paste data into a cell, however, if this data does not match an item in the drop-down list, an error will be generated when the return is uploaded to ESS.
  - The variables in columns C to F describe the details of the specified activity or product listed in column B.
  - Each time any of the variables across columns B to F changes, start a new line. See the example above.
  - Only report active products (i.e., products in use during the reporting period by an active customer).
38. **Column B – Specified Activity or Product** – this column must specify the specified activities or products the firm offered during the reporting period as listed in its scope of authorisation.

39. **Column C – Product or Service offered** – this column must set out the particular product or service offered that falls under the category of the specified activity or product listed in column B. If the firm provides multiple products or services under the same specified activity or product, list each product or service as a separate line item.
40. **Column D – If Other Product or Service offered, please specify** – this column should only be used if the product or service cannot be found in the drop-down list for column C. Provide details of the “other” product or service in column D (free-form text).
41. **Column E – Inherent AML Risk Rating of Product or Service offered in column C** – this column must specify the firm’s inherent AML/CFT risk rating of the product or service using the options provided in the drop-down list (low, medium, or high). If your firm uses a different rating scale, for the purposes of this return, select the risk rating in the drop-down list that most closely matches the firm’s internal risk rating.
42. **Column F – Product introduced during the Reporting Period?** – if the product was introduced during the reporting period, select “Yes” from the drop-down menu, otherwise select “No”.
43. **Column G – Total number of customers using Product or Service offered in column C during the Reporting Period** – provide the total number of customers with same variables in columns B to F. Note that a customer may use for than one product or service.

44. **General instructions:**
- Use the drop-down lists provided. Firms can type or paste data into a cell, however, if this data does not match an item in the drop-down list, an error will be generated when the return is uploaded to ESS.

- b. The variables in columns B to F describe the details of the customers listed in columns G and H.
  - c. Each time any of the variables across columns B to F changes, start a new line. See the example above.
  - d. Only report active customers (i.e., customers that the firm had a business relationship with during the reporting period). For example, where the customer has an open account with the firm, this customer should be reported, even if there was no activity on the account during the reporting period.
45. **Column B – Type of Customer** – this column must specify the type of customer, e.g., retail, corporate, financial institution, etc. If the customer type is a counterparty, e.g., Market Counterparty, select “Eligible Counterparty” from the drop-down list.
  46. **Column C – Nationality or Country of Incorporation of Customer** – this column must specify the nationality (for natural persons) or country of incorporation/establishment (for legal persons or legal arrangements) of the customer.
  47. **Column D – Country of Residence (Individual) or Country of operation (Entity)** – this column must specify the country of residence (for natural persons) or the geographic location of the customer's operations (for legal persons or legal arrangements). Where the customer has operations in multiple geographic locations, select the primary geographic location, e.g., the head office location.
  48. **Column E – PEP?** – This column must specify if the customer is a Politically Exposed Person (PEP). If the customer is a PEP, select “Yes” from the drop-down list, otherwise select “No”.

AML/CFTR rule 1.3.6 defines a PEP, their family members and associates, as follows:

A **politically exposed person (PEP)** means an individual who is, or has been, entrusted with prominent public functions. Unless the context requires otherwise, a reference to a PEP in these rules includes a family member of the PEP or a close associate of the PEP.

Examples of persons who can be PEPs

- 1 Heads of State or of government
- 2 senior politicians
- 3 senior government, judicial or military officials
- 4 members of Parliament
- 5 important political party officials
- 6 senior executives of state-owned companies
- 7 members of senior management (directors, deputy directors and members of the board or equivalent functions) in international organisations.

A **family member** of a PEP means an individual related to the PEP by blood, or by marriage, up to the second degree

Examples of individuals related to a PEP in the first or second degree

- 1 the PEP's father and mother
- 2 the PEP's husband or wife
- 3 the PEP's father-in-law or mother-in law
- 4 the PEP's son or daughter
- 5 the PEP's stepson or stepdaughter
- 6 the PEP's grandfather and grandmother
- 7 the PEP's brother or sister
- 8 the PEP's brother-in-law or sister-in-law
- 9 the PEP's grandson or granddaughter

A person is a **close associate of a PEP** if the person:

- a) is in partnership with the PEP in a legal person or legal arrangement;
- b) is associated with the PEP through a business or social relationship;  
or
- c) is a beneficial owner of a legal person or legal arrangement owned, or effectively controlled, by the PEP.

49. **Column F – AML/CFT Risk Rating of Customer** – this column must specify the firm's overall AML/CFT risk rating of the business relationship with the customer using the options provided in the drop-down list (low, medium, or high). If your firm uses a different rating scale, for the purposes of this return, select the risk rating in the drop-down list that most closely matches the firm's internal risk rating.
50. **Column G – Total Number of New Customers Onboarded during the Reporting Period** – this column must specify the total number of customers onboarded during the reporting period, that meet the same criteria across

columns B to F. Where an account/mandate has been opened for an existing customer, that customer must **not** be considered a "new" customer (they will be counted as an existing customer in Column H).

51. **Column H – Total Number of New and Existing Customers during the Reporting Period** – this column must specify the total number of new customers onboarded during the reporting period **AND** the number of existing customers onboarded before the reporting period that were active during the reporting period, and that meet the same criteria across columns B to F.
52. **Column I – Number of Customers subject to TF-targeted financial sanctions during the Reporting Period** – this column must specify the number of new and existing customers that meet the same criteria across columns B to F and were subject to Terrorism Financing sanctions during the reporting period.
53. **Column J – Number of Customers subject to PWMD-targeted financial sanctions during the Reporting Period** – this column must specify the number of new and existing customers that meet the same criteria across columns B to F and were subject to Proliferation of Weapons of Mass Destruction (PWMD) sanctions during the reporting period.

  - a. Use the drop-down lists provided. Firms can type or paste data into a cell, however, if this data does not match an item in the drop-down list, an error will be generated when the return is uploaded to ESS.

55. **Question Number 1:** Advisors should report "0".
56. **Question Number 1.1:** Report only the Total Assets under Management where business is booked in Qatar. Do not include the value of business booked at an overseas booking centre.
57. **Question Number 2:** if the QFC entity is a subsidiary or a branch, state whether your parent entity or main office has been subject to AML/CFT related disciplinary action during the reporting period. If the answer to 2 is "Yes", then report in 2.1 whether the sanctions have an impact on the QFC entity. If the answer to 2 is "No", then choose "N/A" for 2.1.
58. **Question Number 3:** provide AML/CFT risk rating after the application of controls, as reflected in the firm's Business Risk Assessment conducted in accordance with Rule 3.1.1 of the AML/CFT Rules.

60. Column B – Jurisdiction – this column must list all the jurisdictions that appear in any other sheet in the Q27, i.e., in the Customers, Account/Policies/Engagements, Transactions/Detailed Transactions, STRs and General sheets.
61. Column C – Inherent Jurisdiction Risk – this column must specify the firm's inherent AML/CFT risk rating of the Jurisdiction using the options provided in the drop-down list (low, medium, or high). If your firm uses a different rating scale, for the purposes of this return, select the risk rating in the drop-down list that most closely matches the firm's internal risk rating.

### 61. General instructions:

- The STRs Sheet will only be created if the firm answers "Yes" to the question "Did the firm file any STRs during the reporting period" on the Front Sheet and Declaration.
- Use the drop-down lists provided. Firms can type or paste data into a cell, however, if this data does not match an item in the drop-down list, an error will be generated when the return is uploaded to ESS.
- Complete a new row for each STR filed with the QFIU by the firm, during the reporting period.

62. **Column B – Date (in DD–MON–YYYY format) on which the STR was filed with the QFIU** – this column must specify the date the STR was **filed** with the QFIU, **NOT** the date of the STR, or the date of the transaction or incident.

63. **Column C – Aggregate value of Transaction(s) reported in the STR, in QAR** – this column must specify the total of all transactions reported in the STR.

64. **Column D – Nationality (Individual) or Country of Incorporation (Entity) of Customer** – this column must specify the nationality (for natural persons) or country of incorporation/establishment (for legal persons or legal arrangements) of the customer.

65. **Column E – Country of Residence (Individual) or Country of operation (Entity)** – this column must specify the country of residence (for natural persons) or the geographic location of the customer's operations (for legal persons or legal arrangements). Where the customer has operations in multiple geographic locations, select the primary geographic location, e.g., the head office location.



66. **Column F – Country where Account referenced to in the STR is held** – this column must specify the country where the account is held, which may be different to the country of residence or operation of the customer.
67. **Column G – Country where transaction originated** – this is the country where transaction was initiated, e.g., the location of the ordering customer or remitter for a wire transfer.
68. **Column H – Ultimate destination Country of the Transaction** – this is the country where the transaction ended, e.g., the location of the beneficiary customer for a wire transfer.
69. **Columns H to U** – Respond “Yes” or “No” to each question, as appropriate. A response must be provided in every column H to U – do not leave any columns in a completed row blank.

70. **Question 1** – Tipping off is defined in rule 5.2.1 of the AML/CFT Rules.
71. **Question 2** – Specify the number of updates/revisions to the firm's AML/CFT policies and procedures during the reporting period.
72. **Question 3** – Specify only risk assessments conducted by the firm itself, e.g., business risk assessment or MLRO self-assessments.
73. **Question 4** – Specify audits conducted by the firm, e.g., Internal Audits or reviews and any external audits or reviews.
74. **Question 5** – Specify the number of AML/CFT staff working for the QFC entity only and not the group. This should include staff who provide services to the QFC entity such as non-resident approval individuals and outsourced functions.
75. **Question 6** – Specify both internal and external training programmes.
