We think it's important to learn in different environments. Get ready for an adventure – you could expand your knowledge in a relevant industry here in Qatar or be sent off to another country, with our full support.

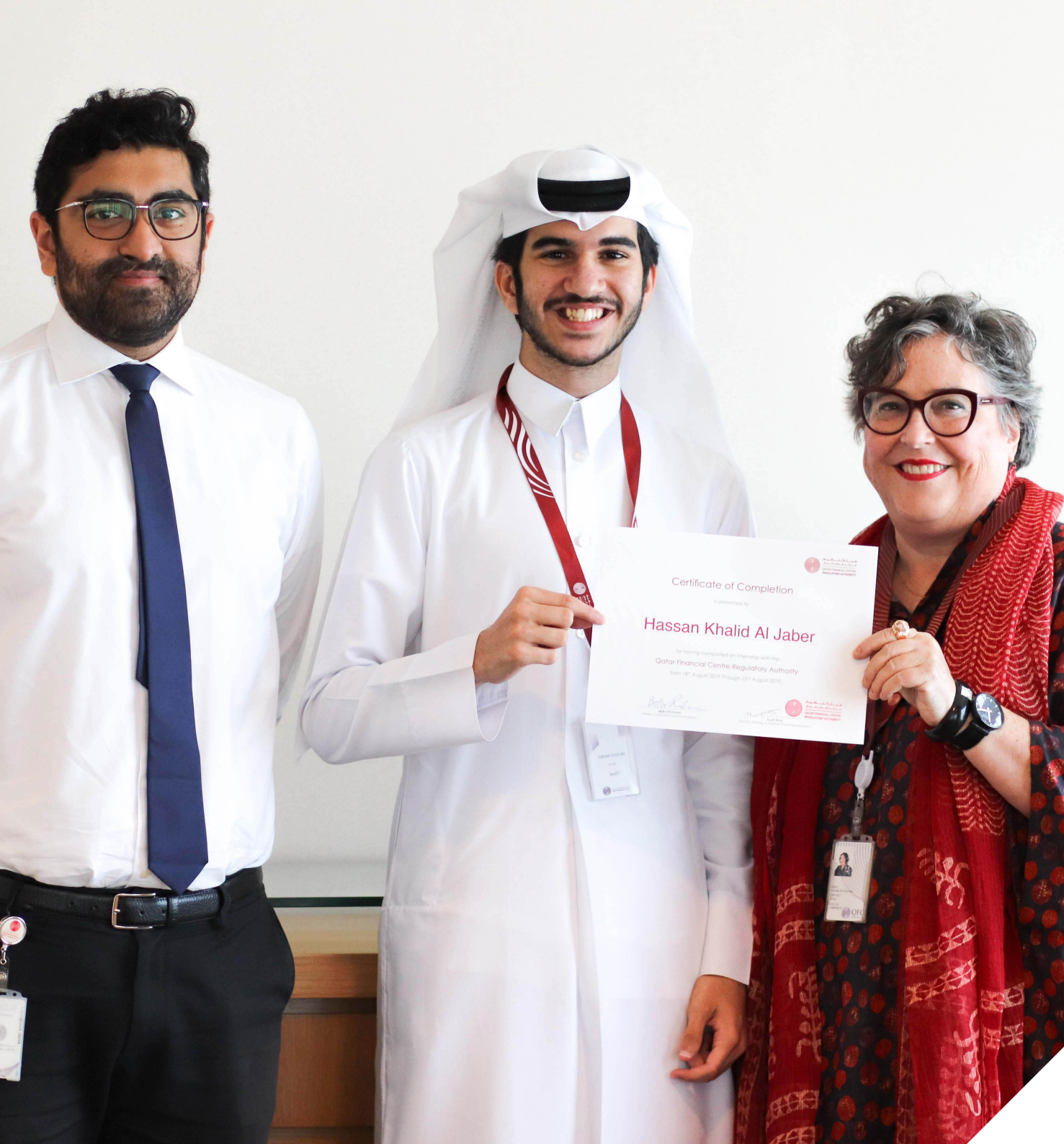
### Stage 04: Expand your qualifications

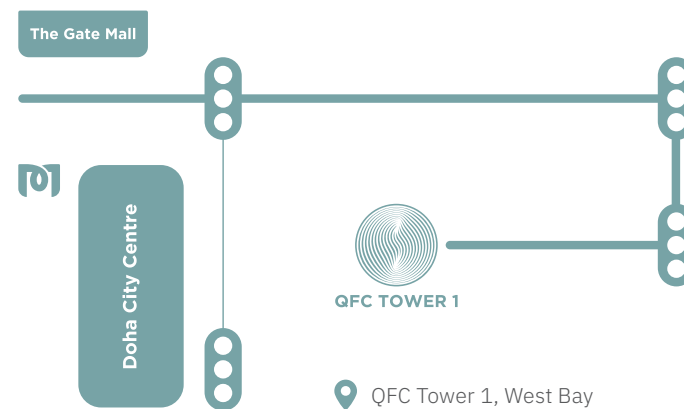
