Summary of QFC Regulations, Rules, Consultation Papers, Firms and Notices

Period: 1 April 2019 - 31 March 2020

The Financial Services Regulations ("FSR"), Schedule 1, Article 22.1(3), states that "the Regulatory Authority is required to provide such other reports to the Council of Ministers on the activities of the Regulatory Authority at such frequency and in such manner as the Council of Ministers may determine (all such reports to be copied to the Governor for review and comment). In 2012, the Council of Ministers requested that this summary be submitted annually, instead of quarterly.

The QFC Regulatory Authority is also required to submit its audited accounts and a report of its activities as soon as reasonably practical after the end of each financial year. This is a separate requirement under article 15 (4) of QFC Law No. (7) of 2005 and is required to be provided to the Council of Ministers. The Regulatory Authority is currently preparing its 2019 Annual Report and it will be filed with the Council of Ministers upon completion.

The QFC activity summary outlined below provides a summary of the following matters for the period 1 April 2019 to 31 March 2020:

- 1. there were 3 QFC Regulations issued during the period;
- 2. the Rulebooks issued by the QFC Regulatory Authority following extensive public consultation;
- 3. the Consultation Papers issued by the QFC Regulatory Authority explaining proposed new rules and seeking feedback from the public;
- 4. the firms authorised by the QFC Regulatory Authority;
- 5. the firms licenced by the QFC Authority;
- 6. the waivers, modifications and revocation notices issued to firms by the QFC Authority and the QFC Regulatory Authority under the requirements of the FSR, Article 16 and the QFC Authority Regulations, Article 13; and
- 7. the policy statements and notices issued by the QFC Authority.
